Community Development Block Grant Public Hearing

Brad Whaley from Sussex County opened the Public Hearing at 7PM and read the public hearing notice.

Discussion regarding block grant; 2.2 million available for Kent & Sussex Counties; benefits low to median income households for housing repairs; has to be owner occupied properties only; insured or insurable; demo and housing rehabilitation projects; Blades has 13 properties currently on the waiting list.

Question from the audience regarding funding for public safety; Mr. Whaley stated that these funds can't be used for public safety projects.

New Castle County has their own allotment; Kent and Sussex County share an allotment.

The town has received over \$384,000 over the past years from CDBG to help rehab homes and demo unsafe structures.

 - o **Synopsis**: recommendation on the bid for the construction for the back up well
 - Aaron Goller with Davis, Bowen, & Friedel; present to make the recommendations for the back up well project. The bids came in over budget and over the available funding. The town has been working with DBF and with the contractor that did come in lower than the other bidder to reduce the cost of the project. Discussion in detail regarding the cost savings and it is detailed line item by line item and is attached with these minutes and in further detail in the recorded minutes. Motion to approve AC Shultes Back-Up Well bid at \$381,479 with condition of amendments and change orders as reads to reduce bid to \$264,913; motion by Councilman Reiss; seconded by Councilman Atkinson; passed unanimously.

❖ Good of the Community:

- ➤ Stand By Me Free one on one financial coaching; program has been in Sussex County for over a year and a half. Beth Pritchett made a brief presentation on how the program works. She handed out brochures.
- Patsy Maharty West, she grew up in Blades, her mother, father, and brother are buried in the cemetery and when she called town hall to question the graves, after some research she was told that there is only one plot left. She became very irate. She discussed her displeasure of this situation and told us that the 2 people in the graves will be dug up even if council has to do it themselves. How would we feel if strangers were buried next to our family? After verbalizing her displeasure, Parks & Cemetery Commission Ruff stated that he will look into the situation and get back with her. (Note for the record: Mrs. West has been very hostile and verbally abusive to the town staff and interrupted the council meeting several times)
- ➤ Ron Dejewski: questioned if the councilman notes regarding the meetings could be elaborated on; what the different meetings are for; what was the purpose of the meetings; why were you attending; please give detail.
