#### Community Development Block Grant Presentation

The **Town of Blades**, Delaware, in cooperation with the Sussex County Council (SCC), and the Delaware State Housing Authority (DSHA), will hold a public hearing so that all citizens can have an opportunity to participate in the development of an application to the State of Delaware Community Development Block Grant Program for a grant under the provisions of the Community Development Act of 1977. The primary objective of the Community Development Program is the development of viable urban communities, including decent housing and a suitable living environment and expanding economic opportunities, principally for persons of low and moderate income. It is also a primary objective to alleviate physical and economic distress through the stimulation of private investment and community revitalization in areas of population out-migration or a stagnating or declining tax base.
