- **New Business:**
- Little Meadows drainage project: Proposition presented by Bobbi Truitt; R & L Services to install catch basins in town right of way / homeowners properties located on Highland Court and Summit Drive. Little Meadows would like to give ownership to the Town of Blades for the catch basin maintenance which should cost approximately \$145 every 10 years. Goal for completion of project: end of February 2019. Commissioner Reiss motioned to move forward with town engineer DB & F overseeing work being done; Commissioner Smith seconded; motion passed.
- Brownfield clean-up proposals given by Brightfields and Environmental Alliance. No vote as not all engineering companies were able to be present.

- New Town Solicitor: Town will schedule William Pepper Sr. with Schmittinger and Rodriguez, P.A. for a council workshop to interview for position. Workshop to be scheduled January 30th, 2019.
