All candidates must

- have attained the age of twenty-five (25) years old;
- have been a resident of Blades for six (6) months preceding this election
- be a U.S. citizen

- March 7<sup>th</sup> is the deadline by which candidates must file a Letter of Intent\* with Town Administrator

# VOTER REGISTRATION INFORMATION

- ➤ March 26<sup>th</sup> at 4:30 p.m. is the deadline by which to register to vote in the April 7<sup>th</sup> election
- > Register at Town Hall
  - > 20 West 4<sup>th</sup> Street || Blades DE
- > Voter qualifications:
  - ➤ Must be 18 years of age
  - ➤ U.S. citizen
  - ➤ Resident of the Town of Blades for at least 30 days preceding the election



# **VOTER REGISTRATION INFORMATION**

- Citizens who have not voted in the last two (2) contested elections must re-register at Town Hall by the March 26<sup>th</sup> deadline
- ➤ Citizens who are unable to come to the **election polls\* located at Hardin Hall: 18 West 4<sup>th</sup> Street, Blades, DE** on the day of the election must complete an affidavit prior to receiving an absentee ballot
- > Completed affidavits must be returned to Town Hall by noon on Wednesday, March 26th
- ➤ Absentee ballots will be available for mailing (to those who completed an affidavit) beginning March 20<sup>th</sup> through March 31<sup>st</sup>
- ➤ All absentee ballots must be received by the Election Board by the close of the at 6:00 p.m. on April 7<sup>th</sup> (Election Day)

<sup>\*</sup> Alternate polling location will be the Town Hall Garage at 20 West 4<sup>th</sup> Street, Blades DE if construction on Hardin Hall is not completed.
